

## GARBAGE COLLECTION

### REGULAR PICKUP: TUESDAY OF EACH WEEK

No tires, or carbonated beverage containers will be picked up because of State law. Each household is allowed to set out ONE large household item each week. Some items such as construction and automotive material will not be picked up except for special pre-arrangement and/or extra cost to the property owner. Appliances that contain Freon, must have freon extracted by a certified contractor and provide proof appliance doesn't contain freon.

### YARD WASTE PICKUP

Will be every other WEDNESDAY beginning in APRIL thru NOVEMBER. You must use paper yard bags or an open garbage can marked Yard Waste. **These cannot weigh more than 30 pounds.**

### ORDINANCES

All residents must get a **Land Use Permit before doing any building (fences,decks,garage,alterations to existing structures)** This is required to get a **building permit from Gladwin County**. Land Use Permits are \$40, make check out to Clement Township. If you are doing Demolition of any kind, call the Gladwin County Building Dept. 989-426-5931, they are now requiring a permit.

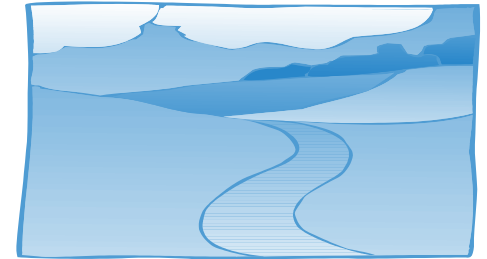

## INFORMATION ABOUT PAYING TAXES

Please mail the top portion only of your tax bill coupon (Winter and/or Summer) to: Clement Township Treasurer: 1497 E. M-30, ALGER, MI. 48610. ***Make check payable to: Clement Township Treasurer***  
**DO NOT SEND CASH IN THE MAIL**

If paying with CASH-you MUST have the EXACT CHANGE, **we DO NOT have a cash register.**

**Please send a self addressed, stamped envelope if you would like a receipt.**

**MULTIPLE PARCELS** If paying on two or more parcels, you may combine all amounts in one check and mail in one envelope with all payment coupons.

**PARTIAL PAYMENTS** Can be made at any time.

**POSTMARKS ARE NOT ACCEPTED AS RECEIVED DATE FOR TAX PAYMENTS**  
**(Please allow 10-15 days for postal delivery.)**

**SUMMER TAXES:** are mailed on July 1st of each year. They are **due no later than September 14th, after that one percent interest is added per month.** As of **Feb. 28th** you must contact the **Gladwin County Treasurer** to pay the delinquent taxes.

**WINTER TAXES:** are mailed on **December 1st** each year. They are **due no later than Feb 28th.**

Penalties and interest will be applied to taxes unpaid as of March 1st. You must contact the **Gladwin County Treasurer** to find out what you owe in taxes.

## **OWNER OF RECORD**

All tax bills are mailed to the Owner of Record. **If your taxes are escrowed, you should send your tax bill to your mortgage lender immediately.** Most mortgage companies contact us for amounts, if you are unsure, contact your mortgage company.
