WHEN REQUIRED: Special Use review is required for all uses which are designed as a Special Use in Article 4 of the Clement Township Zoning Ordinance.

ITEMS TO SUBMIT: All items should be submitted to the Clement Township Zoning Administrator at least **45 days prior** to the desired public hearing date.

1. **Application for Special Land Use Review.**
2. **Site Plans or Plot Plans** - 10 full-sized in addition to 1 digital copy
3. **Site Plan Review Check List or Plot Plan Checklist** in accordance with Article 5 of the Clement Township Zoning Ordinance. Applicable agency reviews as required.

WHEN TO SUBMIT A PLOT PLAN OR SITE PLAN:

Site Plans are required for all Special Uses. For Cottage Industries, the Zoning Administrator may determine that a plot plan may be submitted.
